5.1. Extinguishing media

6.1. Personal precautions, protective equipment and emergency procedures

For containment : Contain spill, then place in a suitable container. Minimize dust generation. Do not flush to sewer

or allow to enter waterways. Use appropriate Personal Protective Equipment (PPE).

Methods for cleaning up : Vacuum or sweep material and place in a disposal container. Provide ventilation. Avoid

generating dust. Use non-sparking tools.

7.1. Precautions for safe handling


